RATE:

The rate for existing hydrants as installed on the system at January 1, 2023,
shall have an annual charge of

\$245,282 Annually

\$ 20,440 Monthly

Rate for hydrants installed after January 1, 2023, shall be determined
in accordance with the Public Utilities Commission Rules and Regulations
Chapter 69.

The hydrant rental charge shall not be reduced, should a Town order
one or more hydrants discontinued.

TERMS OF PAYMENT:

Charges under these rates will be billed and payable quarterly in
advance, at the option of the District. All bills shall be due and payable upon presentation.

Unpaid balances of accounts twenty five (25) days or more past due will be charged interest
at the rate which is set annually by the Public Utilities Commission of the State of Maine.

AVAILABLE:

To customers using the District's service for private fire protection the following rates apply to fire protection only and include no allowance of water for other than fire fighting purposes.

RATES:

For each 6" service line	\$ 2,243
For each 8" service line	\$ 2,989
For each 10" service line	\$ 3,739
For each 12" service line	\$ 4,488

TERMS OF PAYMENT:

Charges under these rates shall be billed and payable quarterly in advance, at the option of the District.

All bills shall be due and payable upon presentation.

Unpaid balances of accounts twenty five (25) days or more past due will be charged interest at the rate set annually by the Public Utilities Commission of the State of Maine.
